BEGINNING APRIL 2010, FEDERAL LAW WILL REQUIRE CONTRACTORS THAT DISTURB LEAD-BASED PAINT IN HOMES, CHILD CARE FACILITIES AND SCHOOLS, BUILT BEFORE 1978 TO BE CERTIFIED AND FOLLOW SPECIFIC WORK PRACTICES TO PREVENT LEAD CONTAMINATION.

Who needs certification?

- ✓ Currently certified Lead Abatement Supervisors and Workers
- ✓ Individuals that perform renovation activities
- ✓ Firms that perform renovation activities
- ✓ Initial training is 8 hr; refresher training is 4 hr.

EPA Requirements

Common renovation activities like sanding, cutting, and demolition can create hazardous lead dust and chips by disturbing lead-based paint, which can be harmful to adults and children.

To protect against this risk, on April 22, 2008, EPA issued a rule requiring the use of lead-safe practices and other actions aimed at preventing lead poisoning. Under the rule, beginning in April 2010, contractors performing renovation, repair and painting projects that disturb lead-based paint in homes, child care facilities, and schools built before 1978 must be certified and must follow specific work practices to prevent lead contamination.
